## **North Dakota Court System - Bar Exam Application**

The North Dakota Bar Exam is a 2-day exam. On Day 1 you'll have six 30-minute Multistate Essay Exam (MEE) questions in the morning and two 90-minute Multistate Performance Test (MPT) questions in the afternoon. Day 2 is the Multistate Bar Exam (MBE), a 200-question, multiple-choice exam (100 questions in the morning and 100 in the afternoon).

## **North Dakota Jurisdiction Information - NCBE**

The North Dakota bar exam is administered twice each year on the last Tuesday and Wednesday of February (if offered) and July in Bismarck, North Dakota. The State Bar Association of North Dakota was formed in 1899. There are 2,900 members in the state, and it is the oldest unified state bar association in the country. North Dakota is one of 30+ states that have adopted the Uniform Bar Examination (UBE). North Dakota first administered the UBE in February 2011.

## **Ultimate Guide to North Dakota Bar Exam, Bar Prep | 2020**

In order to pass the South Dakota bar exam, you must score 130 on the MBE's 200-point scale. The scores of the exam sections are weighted as follows: the written portion 50% and MBE 50%. South Dakota makes bar exam results available approximately 8 to 10 weeks after the exam.

North Dakota administers the Uniform Bar Exam (UBE) that consists of three parts: the Multistate Performance Test (MPT), the Multistate Essay Exam (MEE), and the Multistate Bar Examination (MBE). The exam is scheduled biannually on the last Tuesday and Wednesday of February and July. The MPT and MEE occur on Tuesday; the MBE occurs on Wednesday.
